Oktoberfest Miami Event Vendor Agreement

The Host will be hosting the following event: Oktoberfest Miami to take place at **11919 SW 56 St, Miami, Florida 33175** on **October 10, 11, 12, 17, 18, and 19, 2025**. The vendor is agreeing to vend during the above-mentioned Event, and Vendor desires to vend

(general description of goods to be sold or services to be marketed) at and during the abovementioned Event.

The Host and Vendor parties both agree to the following terms:

- 1. Vendor will be given access to the clubhouse no less than 2 hours before the Event starts to set up the Vendor's station, goods to be sold, and anything else that is needed and customary to vend at the specific location.
- 2. The Vendor will not vend any items or services that are not disclosed here at the Event without prior written consent from the Host.

Event Vendor Agreement

Description of items to be sold:							

- 3. Vendor's station shall be no bigger than 10'x10' feet or taller than 10 feet; shall be clean and orderly; and shall follow all applicable laws and regulations of the County of Miami Dade and the State of Florida.
- 4. Vendor's Staff will be properly dressed, and their appearance will be family-friendly.
- 5. Vendor's Staff may exhibit that goods are for sale only while the staff is within the area of the vendor's specific location.
- 6. Vendor will have access to the location for up to 2 hours following the Event conclusion to dismantle and remove all items brought to the Event by Vendor. Vendor shall leave the location free from trash and in a similar condition that it was in before the vendor was there.
- 7. Vendor agrees to indemnify and hold the Host harmless from all loss, damage, liability, or expenses incurred as a result of the vendors participation in the above-mentioned event.
- 8. If vending food, all food vendors must have food-handling safety certifications for all employees that will be handling food and must comply with food safety laws.
- 9. Please note that vendors are required to come self-sufficient (bring their tent, tables, etc.).

- 10. If and to the extent that the Hosts performance of any of its obligations pursuant to this Agreement is prevented, hindered, or delayed directly or indirectly by fire, flood, earthquake, elements of nature or acts of God, acts of war, terrorism, riots, civil disorders, rebellions or revolutions, or any other similar cause beyond the reasonable control of the Host, then the Host shall be excused for such non-performance, hindrance or delay of those obligations affected by the Force Majeure Event for as long as the Force Majeure Event continues.
- 11. This agreement shall be governed, construed, and regulated in accordance with the laws of the State of Florida, exclusive of its laws of comity and conflicts of laws.
- 12. If "All Days" is selected, Vendor agrees to pay Oktoberfest Miami Vending fee for all days (6 days) in the amount of \$500.00
- 13. If "Day Package" is selected, Vendor agrees to pay Oktoberfest Miami Vending fee for each selected day the amount of \$100.00
- 14. Vendor's station will be located in the outside soccer field.
